A 15% restocking fee will be charged for all non-defective returns. All returns must display a return authorization number on the outside of the shipping carton and must be made within thirty (30) days from the date of invoice, after which NO returns will be authorized. NO call tags will be issued from Joeun. No exceptions. Joeun pays RETURN shipping on replacements when authorized.

Shipping Charges:
